Buying or selling property, purchase of freeholds, lease extensions, transfer of equity, remortgages and agreements with developers.

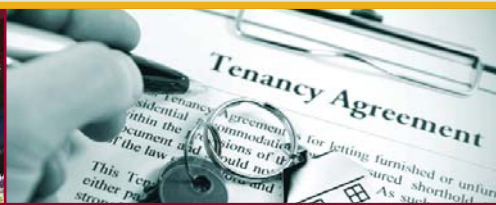

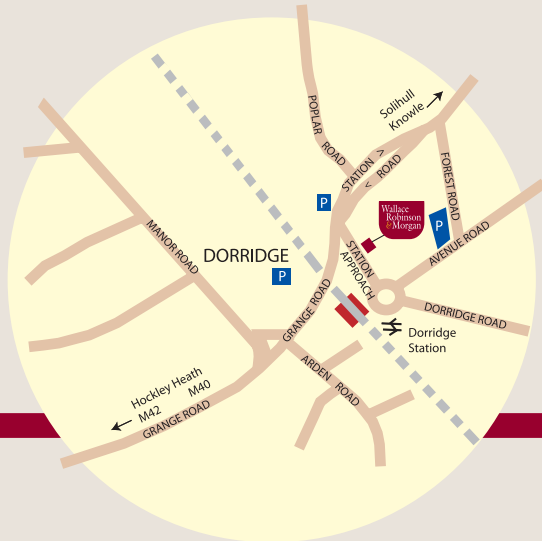
